Judicial Affairs at Regis University

Our Purpose:

The intent in working with students in disciplinary matters is to enhance their growth in various areas including those of developing a sense of personal responsibility for their own discipline and behavior. Accordingly, each student will be treated as an individual within formal disciplinary procedures. These procedures will be instituted at such time as it becomes apparent that informal procedures are unlikely to produce desired changes in behavior or to increase the ability of the student to live with others in a group situation.



The following are seen as purposes for disciplinary proceedings:

- To redirect behavior;
- To protect the rights of others in the community;
- To encourage and teach responsibility for one's own actions.

Frequently Asked Questions about the Regis Judicial Process

I was just documented, what should I do?

You should be receiving a letter under your door that will contain more information, including the time and location of your meeting with a Student Life staff member. If you have additional questions, contact Judicial Affairs or your Residence Life Coordinator.

I received a letter from Judicial Affairs, what happens next?

Be sure to read the letter thoroughly, as it will contain a meeting time and location. If you are unable to attend the meeting at the scheduled time, please call or email the staff member you will be meeting with and request that they change the meeting time.

What happens when I meet with a Student Life staff member?

The meeting is called a Disciplinary Conference, and will give you the opportunity to speak with a Student Life staff member about what happened at the time of the incident. You will have the opportunity to let the staff member know what happened, and the staff member will make a decision based upon all of the information presented.

What if I don't agree with the decision that was made?

If you do not agree with the decision that was made at your Disciplinary Conference, you can always request a Disciplinary Hearing. This will take place with either the Judicial Board or a hearing office from the University Community. Beyond this, you can also request an appeal to the Dean of Students.

What is the Judicial Board?

The Judicial Board is comprised of appointed Regis University students who conduct hearings as part of the disciplinary process. The Judicial Board consists of a Chief Justice who is elected by the student body, and Associate Justices who are appointed by the Chief Justice and voted on by the Regis University Student Government Association (RUSGA).
