1. The Teacher Candidate acknowledges that s/he can access the Regis University Student Teacher Handbook. The Teacher Candidate agrees to become thoroughly familiar with the contents thereof and to seek assistance from her/his University Supervisor if any part thereof is not understood.
2. The Teacher Candidate acknowledges that it is her/his responsibility to become thoroughly familiar with the policies, rules and procedures of the School that will govern h/his activities, presence, and conduct while at the school of the field experience and agrees to seek assistance from her/his Cooperating Teacher and University Supervisor if any aspect or provision of said policies, rules and procedures of the School are not understood.

4. The student acknowledges that while at the School s/he is not authorized to engage in any work or undertake any duties or responsibilities except those directly related to the field experience or those duties and responsibilities incidental thereto.

The student acknowledges and understands that while s/he is engaged in the field experience that s/he has the right to be free from unlawful discrimination, including sexual harassment, and from physical harm and unreasonable emotional abuse. The student agrees that should s/he believe that s/he has been or is being subjected to any such improper or unlawful conduct or activity; s/he will immediately notify an official of the school and of Regis University.

In consideration of the student being allowed to participate in the field experience, the student, hereby acknowledges that s/he has had the opportunity to determine the nature of the activity and the manner in which it will be conducted and having such knowledge or having waived the right to obtain such knowledge does hereby personally assume all risks in connection with said activity and further releases Regis University, its instructors, agents, employees, operators, officers, and trustees from liability for any harm, injury or damage which may befall the student while engaged in this activity, traveling to or from the activity site or arising from the student's presence at the site or in the site vicinity, including all risks connected therewith, whether foreseen or unforeseen, and whether arising from the negligence of Regis University, its instructors, agents, employees, volunteers, operators, officers or trustees.
